

SUMMARY ANNUAL REPORT

For Gunderson Dettmer Stough Villeneuve Franklin & Hachigian, LLP Health and Mental Welfare Plan

This is a summary of the annual report of the Gunderson Dettmer Stough Villeneuve Franklin & Hachigian, LLP Health and Mental Welfare Plan, EIN 77-0409988, Plan No. 502, for period 01/01/2024 through 12/31/2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Gunderson Dettmer Stough Villeneuve Franklin & Hachigian, LLP has committed itself to pay certain self-insured Dental claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with Vision Service Plan, Kaiser Foundation Health Plan, Inc., Cigna Health and Life Insurance Company and Affiliates, Blue Cross Blue Shield of Massachusetts, Inc, Unum Life Insurance Company of America, Four Ever Life Ins. Co., Zurich American Insurance Company, and Spring Health to pay Medical, Dental, Vision, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, and Employee Assistance Program claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2024 were \$12,838,052.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2024, the premiums paid under such "experience-rated" contracts were \$5,061,958 and the total of all benefit claims paid under these contracts during the plan year was \$3,933,705.
